Notice of Motions

5. Motion from Councillor Des Guckian

That the junction of the L1601 (old road to Dromod) and the N4 at Faulties townland be cleaned up and tidied. There are a lot of weeds and dirt there and the "triangles" could be

brightened up by luminous paint to make them more visible.

6. Motion from Councillor Des Guckian

That this Council investigates the possibility of installing a WWTP at Kilclare, as there are many houses in that part along the Carrick & Ballinamore boundary which need such a service.

7. Motion from Councillor Sean McGowan:

I ask Mr Joseph Gilhooly, Director of Services Infrastructure to include the provision of a walkway / cycleway from Killinaker Bridge as far as Dromod as the final link between the two villages of Rooskey & Dromod, for funding under the Active Travel programme 2022.

8. Motion from Councillor Sean McGowan:

I ask Mr Joseph Gilhooly, Director of Services Infrastructure to look at the possibility of Leitrim taking a lead in a "Vision for Cycling in Rural Ireland". This initiative, which was launched in 2020, is spearheaded by a Leitrim woman, and one of its aims is to create an environment where "Cyclists are Expected and Respected". I believe that there is huge potential to make this work here in Leitrim.

9. Motion from Councillor Finola Armstrong McGuire:

May I ask for a progress report on Stage 2, Carrick-on-Shannon Town Centre Development. What progress has been made regarding developments in the area near the bus stop, at the Linear Park and from Cryan's Hotel to Carrick Café.

10. Motion from Councillor Finola Armstrong McGuire:

May I ask that advice is given to business owners who take care of footpaths in front of their premises in Carrick-on-Shannon.

The new streetscape is lovely, however the stains from food or spillages are unsightly. I am concerned that the wrong abrasives may be used and damage the surface. I would appreciate if maintenance advice could be shared with the general public.

11. Motion from Councillor Enda Stenson:

I call on the Council to secure funding under Active Travel Scheme for the provision of public lighting and footpath connecting Glas na hAabhainn, Carrick-on-Shannon to the crossroads at Attirory, with a view to essentially making this route safe for pedestrians. Apart from 26 fully occupied detached houses in Glas na hAbhainn estate, this route is very popular with pedestrians from the densely populated area in Attirory, using this road for daily exercise. Developing lighting and the footpath in this area will entice those who choose to pursue a more active means of transport due to the safety provided by this enhanced infrastructure.

12. Motion from Councillor Enda Stenson:

I wish to thank our engineers for securing funds to repair and rebuild the roadway to Lough McHugh, Eslin Bridge, and appreciate the continued commitment of Waterways Ireland to the upkeep of this wonderful amenity. I ask when will this work commence on this road.

13. Motion from Councillor Paddy Farrell:

I call on Leitrim County Council to examine ways of calming/slowing traffic at the Homeland Kiltoghert Store, as residents on opposite sides of the road have great difficulty getting out on the road with the current speed of traffic coming from the Leitrim Village direction.

14. Motion from Councillor Paddy Farrell

I call on Leitrim County Council to erect more speed and safety signage on the L-3409 and L-3410 local roads - the road from Church Park to Kilnagross – to ensure the safety of road users.
